

The Roberts County Commissioners met in regular session with Don Carlson, Dennis Jensen, Faye Johnston, Tom Vergeldt and Tim Zempel present. Chairman Jensen presiding. Jason Deutsch-Sisseton Courier livestream.

The Pledge of Allegiance was recited.

Motion by Johnston, seconded by Vergeldt to approve the agenda as presented and the May 24, 2022 minutes. Motion carried.

EXECUTIVE SESSION

MALT BEVERAGE

HIGHWAY

Pat Stickland met with Commissioners. Discussion took place regarding road issues and the load limits have been lifted on county gravel roads. Stickland also mentioned bridge on a township road located between 132nd St and 460th Ave has been decreased to a 3 ton weight limit.
