The Roberts County Commissioners met in regular session with Don Carlson, Dennis Jensen, Tom Vergeldt and Tim Zempel present. Faye Johnston absent. Chairman Jensen presiding. Jason Deutsch-Sisseton Courier livestream.

The Pledge of Allegiance was recited.

Motion by Carlson, seconded by Vergeldt to approve the agenda as presented and the December 7, 2021 minutes. Motion carried.

PUBLIC COMMENT

Jensen called for public comment. Vergeldt received a phone call regarding snow removal on Lake Road. He will visit with Pat Stickland.
