PUBLIC HEARING/PETITION FOR VACATION OF PART OF PRIVATE ROAD

Shari Gamber and Nikolas appeared for Public Hearing on Petition for Vacation of Part of Private Road in Lockwood Township. After discussion, motion by Carlson, seconded by Zempel to approve and adopt the following Resolution and Order:

RESOLUTION 2019-43 AND ORDER

The Board of County Commissioners of Roberts County, South Dakota, presented the following Resolution and Order and moved it adoption:

WHEREAS, a Petition having been received asking for the vacation of a part of a Private Road described as:

The Private Road between Lots Five (5) and Ten (10) as above described, commencing at the Southwest corner of Lot Ten (10), hence Northeasterly Sixty-seven and 1/10 Feet (NE 67.1') along the southwest boundary of said Lot Ten (10), hence Southeast Twenty eight and 3/10 Feet (SE 28.3') at a 90 degree angle to the boundary of Lot Five (5) as above described, hence Southwesterly Sixty Feet (60') along the Northwest boundary to the Northwest corner of said Lot Five (5), hence Northwesterly approximately Twenty-eight and 3/10 (NW 28.3') to the point of origin, containing approximately 1,608 square feet; and further said petition being in proper form and executed by the required number of electors of Lockwood Township; and further it having been determined after the public hearing having been held after proper notice, upon due consideration by the Board of County Commissioners of Roberts County, South Dakota and said Commissioners having considered said matter and being fully advised in the premises and considering it expedient and advisable to do so;

NOW, THEREFORE, BE IT RESOLVED, AND IT IS HEREBY ORDAINED:

That the said part of the Private Road described as:

The Private Road between Lots Five (5) and Ten (10) as above described, commencing at the Southwest corner of Lot Ten (10), hence Northeasterly Sixty-seven and 1/10 Feet (NE 67.1') along the southwest boundary of said Lot Ten (10), hence Southeast Twenty eight and 3/10 Feet (SE 28.3') at a 90 degree angle to the boundary of Lot Five (5) as above described, hence Southwesterly Sixty Feet (60') along the Northwest boundary to the Northwest corner of said Lot Five (5), hence Northwesterly approximately Twenty-eight and 3/10 Feet (NW 28.3') to the point of origin, containing approximately 1,608 square feet; be and hereby is declared to be vacated; and further that this Resolution and Order be written in the minutes of the Board;

IT IS FURTHER ORDERED that said Resolution shall be published in the Wilmot Enterprise once each week for two (2) consecutive weeks; and that after such publication, such part of the Private Road shall be, after the lapse of thirty (30) days, vacated without further proceedings unless appealed as provided in SDCL 31-3-14; and that the Roberts County Auditor herein is further directed to cause to be recorded a true and correct certified copy of this Resolution and Order in the office of the Register of Deeds in and for Roberts County, South Dakota.
