The Roberts County Commissioners met at 9:00 am in regular session with Tom Vergeldt, Don Carlson, Faye Johnston, Brian Heinecke, Tim Zempel, Kristi Fritz and Dylan Kirchmeier present. Jason Deutsch-Sisseton Courier livestream. Chairman Vergeldt presiding. Vergeldt called the meeting to order and led the pledge of allegiance. MINUTES/AGENDA

Motion by Carlson, seconded by Heinecke to approve the December 31, 2024, agenda and minutes for December 24, 2024, as corrected to add Ken Nelson-appointed Commissioner Dist. 3 also in attendance. All voted aye, motion carried. PUBLIC COMMENT

Robert Horton, Robert Vassallo, Gary Sheldon and John Dabek Jr. appeared for public Comment. Robert Horton is disappointed in the appointment of Ken Nelson and questioned if he even pays property taxes in Roberts County. Robert Vassallo also questioned if the Board would list all who applied in the minutes. The Board did not think paying property taxes was a requirement for Commissioner and all who applied for District 3 was private information. States Attorney Kirchmeier stated that residency in the jurisdiction is the only requirement for being a county commissioner.

STATES ATTORNEY

Dylan Kirchmeier-States Attorney presented his year end statistics as follows: Approximately 800 new CRI filings in 2024 compared to 740 in 2023, 839 in 2022 and 1017 in 2021; Closed adult files: 1040 in 2024, 1077 in 2023, 1019 in 2022, 841 in 2021; Approximately 140 ne Juvenile filings in 2024, 124 in 2023, 128 in 2022, 174 in 2021; Closed Juvenile files: 125 in 2024, 140 in 2023, 112 in 2022, 137 in 2021; Carrying over 430 adult cases that have been scheduled for court appearances, probably closer to 500 w/cases that are scheduled for first appearances after January 1. 277 of the 430 have active warrants and 300-400 cases with active warrants have not had court appearance since Kirchmeier has been here. Carrying over 40 juvenile files which is probably closer to 50 with cases that are scheduled for first appearance after January 1 and 16 of the 40 have active warrants.

Four A & N cases this year with 3 done and 1 on-going. The jury has reported three times with 2 convictions and one no show defendant, 7 court trials all ending in convictions. Of the 1040 closed adult files, 313 were dismissed due to plea agreements involving other cases here or other counties, lack of evidence, discovery of exculpatory evidence or deferred prosecution agreements. The States Attorney's office has a 70% conviction rate.

County comparison for CRI filings as of 12/26/24: Roberts 775, Marshall 43, Grant 131, Day 140, Brown 1342, Codington 1554, Hughes 547, Clay 383, Brookings 975, Butte 380, Beadle 459, Charles Mix 353 and Lake 243.

EMERGENCY MANAGEMENT

Paige Schaunaman-Em Mgr. met with the board and discussed her training. Motion by Carlson, seconded by Zempel to pay necessary expenses for training on April 23 & 24 in Pierre, SD. All voted aye, motion carried.

SCOTT GERMAN Scott German presented Don Carlson with a star quilt for all his years of public service to District 3 as a County Commissioner. German has also spoken to the tribal chairman regarding cost sharing the purchase of a new van for the county coroner.

LANDFILL

Jamie Dahl met with the Commissioners and discussed rate increases for 2024. Dahl will send out a letter to all concerned that rates would increase by 10% as of January 1, 2025.
