

The Roberts County Commissioners met at 9:00 am in regular session with Tom Vergeldt, Brian Heinecke, John Dabek Jr, Ken Nelson, Kristi Fritz and Dylan Kirchmeier present. Faye Johnston absent. Also, in attendance were Robert Horton and Gary Sheldon. Jason Deutsch-Sisseton Courier livestream. Chairman Vergeldt presiding. Vergeldt called the meeting to order and led the pledge of allegiance.

MINUTES/AGENDA

Motion by Nelson, seconded by Heinecke to approve March 4, 2025, agenda and minutes for February 25, 2025, as amended to add Burial application to agenda and explanation of contract signed with Vanguard under Director of Equalization. All voted aye, motion carried.

PUBLIC COMMENT

There was no public comment.

ROBERT HORTON

Robert Horton met with the Board to discuss the status of the two parcels of land the Register of Deeds office was researching regarding eminent domain along old US 81 which was incorrectly listed in the January 28 proceedings as State Hwy 81. The Register of Deeds office is researching the whole County not just the two parcels in question which will allow the Board to resolve all parcels at the same time. Horton also asked the Board to read SDCL 28-13-04.

STATES ATTORNEY

Dylan Kirchmeier-States Attorney asked for a decision on the refund request received from Anthony Tokarczyk for the 2023 payable 2024 taxes which he presented last week.

Motion by Heinecke, seconded by Nelson to deny refund request #2137 for Tokarczyk property as the 2023 property assessment was not appealed to the Board of Equalization in 2023. All voted aye, motion carried.

Kirchmeier also asked for changes in writing for Resolution 2025-09 from the Board.

SHERIFF

Tyler Appel-Sheriff presented a prisoner count of 66. Appel explained the Roberts County Jail is now certified to provide Rehabilitative/Restorative services for inmates rather than taking them to Minnehaha County for this service. This service, if ordered by the judge, is also reimbursable through the Dept. of Social Services.
